St. Stephen's needs your help with filling open board positions!

The following 4 board positions begin January 1, 2026 and are a 3 year term. If you are interested or need more information, please talk to the Elders or Pastor. Below is a description of the open board positions.

FINANCE BOARD: This position shall receive and deposit all contributions of the members of the congregation and turn over all records of receipts to the Treasurer. They shall keep an accurate account of all individual contributions and shall render an annual printed report to the congregation. Weekly deposits are made at the Atkins Savings Bank.

<u>OUTREACH BOARD:</u> This position shall maintain a program to greet and welcome visitors at all regular worship services. They shall also be responsible for planning, promoting, and carrying out an outreach program in the congregation and community. They share the responsibility with other Outreach Board members to serve coffee and treats for fellowship time after church services.

PARISH EDUCATION: This position stimulates and maintains the proper interest in the members of St. Stephen's congregation regarding Christian Education. The Sunday School Superintendent, in addition to being a member of this Board, is the Pastor's chief assistant with regard to the Sunday School and shall exercise detailed supervision over the entire Sunday School program. This Board shall encourage the spiritual growth of the members through the various educational agencies within the congregation (such as Sunday School, midweek classes, Vacation Bible School, youth and adult Bible classes). They will plan for, make suggestions to, and promote member involvement in these agencies so that all members may grow in Christian knowledge and ability.

YOUTH BOARD: This position makes sure that there is support for the youth and their programs in the congregation. They shall encourage the youth to become involved in the youth programs, see that youth activities are publicized, seek appropriate volunteers to assist with the youth programs, and provide encouragement and support for these people.
